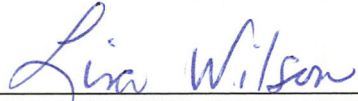

PART-TIME POLICE OFFICERS.**

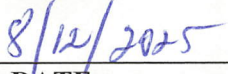

BOARD MEETING ADJOURNED.

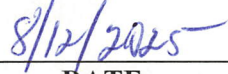
UPON, motion by Alderman Ella Green and seconded by Alderman George Walker with all members voting aye, the Recessed Meeting was adjourned.
